FEES STRUCTURE

Since AAOIFI is a **not-for-profit making organization**, the fee structure is designed to accommodate and allow participation from a broader base of industry practitioners. The fee structure allows the candidate to choose from the following two options:

- Option 1: USD \$1,200
Program Registration fees* + Study packages + Examination fees + Membership Fees
- Option 2: USD 200
Exam retake fees

Annual fees:

Candidates who pass their examinations are subject to annual professional fees of USD 100.00.

Failure to settle the annual professional fees of USD 100.00 will result in your name being removed from the list. In such cases, you will only be re-admitted to the list if you pay all relevant fees again.
